Holiday Cash & Dash 2017 2nd Chance Promotion

Drawing Rules

OVERVIEW:

Beginning any time on Monday, October 23, 2017, until 11:59:59 PM on Monday, January 15, 2018, players can enter the Holiday Cash & Dash 2017 2nd Chance Promotion ("Promotion") offered by the Maryland State Lottery and Gaming Control Agency ("Lottery" or "Maryland Lottery") for a chance to win a Warehouse Dash® in Chicago ("Warehouse Dash"), travel, cash, and Maryland Lottery scratch-off tickets ("Scratch-Offs" or "Scratch-Off"). Enter at mdlottery.com/holiday non-winning Maryland Lottery® 2017 holiday scratch-off tickets (#344 Candy Cane Cash, #345 Gifts Galore, #346 Polar Payout, #347 Holiday Riches and #348 Winter Ice Multiplier), and/or any other ticket specified by the Lottery (collectively, "Tickets"; singular "Ticket"). The number of entries received for a submitted Ticket equals the price point of the Ticket, i.e., \$1 Ticket equals one (1) entry; \$2 Ticket equals two (2) entries, etc.

The Lottery will conduct a series of twelve (12) 2nd Chance Drawings ("Drawings"; singular "Drawing") throughout the Promotion. Prizes include a total of twelve (12) Warehouse Dash prizes, five (5) \$10,000 cash prizes, five (5) \$5,000 cash prizes, one hundred twenty (120) \$1,000 cash prizes, and one hundred twenty (120) Scratch-Off prizes. A total of 262 winners will be selected to win an estimated total of \$590,071 in experiential prizes, cash and Scratch-Offs.

For each Drawing: Entries must be entered for a specific Drawing by 11:59:59 PM Eastern Time on the announced drawing entry deadline date to be eligible for that Drawing. (In these Rules, all times are Eastern Time.) Entries are not cumulative. Each Drawing must be entered individually to be included in that Drawing. **See the Drawing Chart below for drawing entry deadlines, Drawing dates, number of winners, prizes and claiming deadlines.** These are bonus Drawings, and the \$10,000, \$5,000 and \$1,000 cash prizes are bonus prizes.

Internet access and a valid email address are required to enter this Promotion and its Drawings. Mailed entries will not be accepted. You may enter as often as you like; however, you may only win:

- once per drawing;
- one (1) Warehouse Dash prize throughout the Promotion; and

YOU DO NOT NEED TO KEEP YOUR ORIGINAL TICKET IN ORDER TO CLAIM YOUR PRIZE IF YOU WIN. (Players and winners are sometimes referred to as "you" and "your".) A qualifying entry is one (1) Ticket. A Ticket may only be used to enter one time. The number of entries per Ticket is equal to the price point of the Ticket.

To enter, you must be 18 years of age or older. All winners must be at least 18 years of age.

Dasher's Dash Interactive Game:

- Players entering Tickets into My Lottery Rewards ("MLR") will be prompted to play the interactive Dasher's Dash" game ("Game"), a Skill-With-Reveal hidden object game that takes players to a holiday village with a dozen game play locations.
- You are not required to play the Game when entering your Tickets. You may choose the Opt Out feature of the Game.
- You will still receive the MLR points and the second-chance entries associated with each Ticket entered, even if you opt out of the Game.
- If you choose to play the Game, you are given 60 seconds to find 6 (six) hidden objects.
- Finding objects quickly awards bonus points within the Game, and new locations can be unlocked by entering additional Tickets.
- You can continue to play previously unlocked locations for fun.
- You can login to your social media account to share your scores.
- After each Game, you can compare your score with other players by viewing the daily and all-time leaderboards.

PRIZE DESCRIPTIONS:

Warehouse Dash®:

Twelve (12) winners, (one (1) from each of the twelve (12) Drawings) will be selected to win a Warehouse Dash, travel, and \$500. Each Warehouse Dash will include a three (3) day, two (2) night trip for two (winner and one guest) to Chicago, Illinois, roundtrip coach airfare for up to two (2) people from any U.S. International airport to Chicago, Illinois (inclusive of all associated security fees, taxes and

surcharges) or travel allowance up to \$1,200 for a winner that elects to drive to Chicago, all ground transfers between the destination airport, hotel and MDI sponsored events, deluxe double occupancy room for two (2) nights at a three diamond rated hotel or better, and \$500 spending money for the winner to be provided in the form of a check two (2) weeks prior to the scheduled trip departure date. Winners and guests will be honored with a welcome reception/dinner the evening of their arrival in Chicago.

The Warehouse Dash will also include admission for winner and guest to the Maryland Lottery Dash Event (“Dash” or “Dash Event”) located at the Hinda, Inc. (“Hinda”) warehouse, where the winner and guest will have an opportunity to participate in a ninety (90) second dash through the Hinda warehouse. Either winner or guest can be designated as the one who can place as much merchandise as the designated person can into the winner’s shopping cart. Winner is solely responsible for the actions of the guest who accompanies the winner to events. Estimated prize value: \$28,679 each including tax withholdings.

\$10,000 Cash:

Five (5) winners will each receive a cash prize of \$10,000.

\$5,000 Cash:

Five (5) winners will each receive a cash prize of \$5,000.

\$1,000 Cash:

One Hundred Twenty (120) winners will each receive a cash prize of \$1,000.

Scratch-Offs

One Hundred Twenty (120) winners will each receive \$300 in \$5 Scratch-Offs.

All winners, including alternate winners (“Alternates” or “Alternate”), must claim your prize by 4:30 PM on the respective claiming deadlines shown above.

All aspects of this Promotion are governed by these Drawing Rules (“Rules”) and the Maryland State Lottery and Gaming Control Agency Points For Prizes®/Points For Drawings®/2nd Chance Drawings Official Rules and Conditions Of Eligibility (“Official Rules”). If any discrepancy exists between these Rules and other material describing the Promotion or anything related thereto, these Rules shall prevail.

CLAIMING:

You will be advised, at the time of notification, of claiming procedures and reminded of claiming deadlines. Claiming deadlines for winners, including Alternates, are included in the chart above. Winners of the Warehouse Dash, \$10,000 and \$5,000 prizes must claim your prize in person by 4:30 PM of the claiming deadline date at the Maryland Lottery Baltimore Customer Resource Center, Montgomery Park Business Center, 1800 Washington Boulevard, Suite 330, Baltimore, MD 21230. Winners of the \$1,000 prize and the Scratch-Off prize may claim your prize in person at, or by mail (with a Lottery Claim form and required documentation) to, the address in the preceding sentence, or through email or facsimile transmission. An email address and/or fax number will be provided upon request. Winners must allow a minimum of 15 business days after the Lottery receives a claim for delivery of your prize. If a winner has been disqualified, or by the relevant claiming deadline has not claimed, submitted all required documentation, and been confirmed and validated as eligible, then an Alternate winner may be selected. Alternates must claim by 4:30 PM of the claiming deadline designated for Alternates.

MDI will completely fulfill the Warehouse Dash prize, including all items won during the Dash Event. MDI will pay the estimated State and Federal tax withholdings for the Warehouse Dash prize, including all items won during the Dash Event, and you will receive a W-2G form from MDI for this prize. You will receive a W-2G form from the Maryland Lottery for the \$10,000, \$5,000 and \$1,000 prizes. All amounts paid to you or on your behalf will be included in your reportable income. You will be taxed on those amounts. All winners are responsible for all taxes, including income taxes.

All items won during the Dash Event will be inventoried by Hinda and then shipped by Hinda within ten (10) business days after the Dash Event to the respective addresses of the winners as listed in the My Lottery Rewards registration.

ADDITIONAL RULES:

If the winner is traveling via air and fails to appear at the designated time and place of departure and/or fails to check into the hotel after arriving in Chicago, the winner forfeits the balance of the Warehouse Dash prize with the exception of the \$500 cash portion, less any tax withholdings; unless Prizewinner makes his or her own replacement travel and/or lodging arrangements at Prizewinner’s expense. If the winner fails to arrive for the scheduled participation in the Dash Event, the winner forfeits the right to personally participate in the Dash Event. However, in any of those three situations, two (2) proxies will be appointed to play the Dash for the winner, and the winner shall receive any prizes won by the proxies.

In the event a winner is unable to attend the Dash Event due to unforeseen and reasonable circumstances, the balance of the Warehouse Dash prize shall be forfeited with the exception of the \$500 cash portion of the Warehouse Dash; however, two (2) proxies will be appointed to play the Dash for the winner, and the winner will receive any prizes won by the proxies.

If a winner has a physical limitation that may prevent the winner from participating in the Dash Event but still intends to attend the Warehouse Dash, the winner must travel with a companion that is capable of participating in the Dash Event. One (1) proxy will be appointed to assist the winner’s companion during the Dash.
